- 11/17/2015 Attention Deficit Hyperactivity Disorder, ADHD, unspecified ADHD type Past meds-Ritalin
- 10/11/2013 Seizures, generalized convulsive

Two seizures soon after stopping synthetic marijuana substance, due to withdrawal (neurology referral)

- 10/11/2013 Back pain of thoracolumbar region
- 10/11/2013- Allergy induced asthma Current Medications-Albuterol Inh 90mcg/ACT, two puffs every two hours (Asthma)
- 10/11/2013 Hasn't gotten neurology referral. Wants mental health referral
- 09/27/2013 -

Had two seizures a month apart at work in March, 2013. Just moved from Missouri and was stressed, evicted, and lost van. blacked out and woke up in the hospital. ER reportrecurrent seizure, lip laceration and mandible dislocation. Used Dilantin for 2-3 weeks but gave him stomach cramps, diarrhea. Stopped smoking synthetic marijuana and seizures started occurring more frequently. Other withdrawal symptoms-sweating. Grandmother had epilepsy.

Back pain from construction work in 2001.

Referrals to radiology for xray (back pain)

Active Problems

- 9/14/2014- Idiopathic Epilepsy and Epileptic syndromes, generalized convulsive epilepsy, not intractable, without status epilepticus
- 9/17/2014 ADHD
- 9/17/2014 Unspecified asthma, uncomplicated asthma
- 9/17/2014 Rash and other nonspecific skin eruption
- 9/17/2014 Hypopotassemia: chronic (low potassium concentrate in blood)

Medications

- Lamotrigine 100MG for seizure control
- Hydroxyzine 25mg Pamoate for sleep
- Gabapentin 600mg for seizure control
- Buspirone 30mg for anxiety

#### 9/17/14

Had first seizure in two years. Found on bathroom floor, took him to ER. Took about 3 hours to come around after 5 minute seizure. **Seizure** advised to start on Keppra (anti-epileptic) 500mg BID. C/O Keppra making him tired. C/O itchy rash and jaw pain.

#### 10/1/14

Has to be seizure free for six months before he can drive (clearance from neurology). Seppra makes him tired. Wants to go back to Ritalin for ADD and treat with THC for seizures because of no side effects. Needs to contact DSHS for voc rehab.

### 5/28/15

PT request for SSI stating he was seen after seizure in September. **The seizure** is seeing a neurologist and is taking Zonisamide 100, Gabapentin 400 TID and Sertraline 100. Sees dark shadow in periphery LT eye; decreased hearing and chronic neck/back pain. No seizure since December.

## 6/8/15

Side effects from meds. Defect result from back xray. Same complaints from 5/28/15, shadows in eye. Severe TMJ instability (jaw).

7/1/15

Mood disorder, epilepsy, back pain.

8/10/15 – Nooksack Physician

PT lost control of car yesterday morning due to "blacking out" and driving into the woods. No other vehicles were involved or Police or EMS. He was able to self-extricate and contact his fiancé who helped him move his car. She was worried PT had a seizure. Pt denies use of illicit drugs or alcohol. Says he stopped Gabapentin x five days due to over sedation and "personality changes," cannot remember specifically what changes. "Can't remember, but I'm not myself." Feels confused, slow, fatigued. Has not been sleeping well, mood is irritable. Sees a counselor regularly.

9/1/15 – , Nooksack Health Clinic

Been taking medications for about a month. Supposed to be on gabapentin still but doesn't like it. Has stopped taking Zonisamid and Zoloft because he doesn't like the way he feels while on those meds. Makes him tired but can't sleep at night. Neurologist started on lamotrigine but pt stopped because he was told he would break out in hives or shingles. Has difficult time concentrating and does not want to be there. Has a desire to work but can't because of seizures, anxiety, and depression.

Notes about family history. Does not want to be taking pills anymore as "they mess me up." Side effect: nausea. Has nobody to talk to and is angry at his mother for being homeless and other issues. C/O mood swings, irritability, depression, anxiety.

Occasional alcohol use, previous tobacco use, current marijuana use. Denies suicidal ideations or plan, wishes he "weren't alive." Discussed trying a single dose medication, lamictal, it will take time for them to be effective and side effects are normal. Counseling sessions, let go of anger about past and focus on the present. Promethazine for nausea and Buspar for anxiety.

# 9/30/15

Keeps starting and stopping meds. Has been working filleting fish. Anxiety, not sleeping well. New diagnoses: Acute-on-chronic vesicular eczema of hands, abnormal vision, hearing difficulty, chronic back pain, temporamandibular subluxation, lumbar spondylosis, mood disorder, acute confusion, anxiety disorder, depressive disorder, tinea pedis, carpal tunnel syndrome, joint-pain-dysfunction syndrome, fatigue.

12/10/15

Has disability attorney. No longer working,

# PeaceHealth

1/1/16 -

Transported by ambulance for altered consciousness. Postically has confusion. Missed dose of anticonvulsant, Lamictal. Does not remember what happened. Went to get coffee and woke up in hospital. Surgeries: Appendectomy. Social: Marijuana, nonsmoker, no alcohol use, local resident with good social support. Back and neck pain. Subtle nondisplaced fracture on vertebral body. Negative results for ethanol.
