On March 31, 2016 at 12:45pm I spoke with [REDACTED], sister of [REDACTED]. She gave me her brief understanding of [REDACTED] relationship with [REDACTED]. [REDACTED] said that [REDACTED] was always in messy dramatic relationships throughout her life. [REDACTED] was known to be manipulative and verbally abusive as she would yell at [REDACTED] a lot. [REDACTED] said that she's never seen [REDACTED] hit a woman and states that he is a "good guy." [REDACTED] knows that [REDACTED] was more physically abusive in her previous relationship but only verbally abusive with [REDACTED]. I asked [REDACTED] if she knew how happy they were in their relationship and stated that they seemed happy at first, but she was "pretty sure it wasn't going to last." [REDACTED] said that [REDACTED] had started acting weird recently and has trouble remembering things. [REDACTED] was on bi-polar medication while she was pregnant. Bi-polar runs in their family as [REDACTED] and [REDACTED] father were diagnosed with bi-polar disorder; however [REDACTED] has not been officially diagnosed. [REDACTED] said she does not have anything more to say regarding their relationship. [REDACTED] says she likes [REDACTED] he is "a good guy" and has nothing else to say regarding his relationship with [REDACTED].

On March 31, 2016 at 1:00pm I also spoke with [REDACTED], friend of [REDACTED] and [REDACTED]. [REDACTED] said that she has known them for a couple of years. [REDACTED] was unsure of what to say so I asked her what her impression was of their relationship and she had "nothing bad to say" as she did

not ever witness any forms of verbal or physical abuse. [REDACTED] said their relationship was overall happy until [REDACTED] became pregnant. [REDACTED] became mean during the pregnancy and [REDACTED] was told by people that [REDACTED] was depressed and "changed a bit." [REDACTED] said [REDACTED] can be "kind of a crazy person." [REDACTED] and [REDACTED] split up around December of 2015, and [REDACTED] was surprised when they broke up. [REDACTED] said [REDACTED] son is now two years old and she would go over to babysit often because [REDACTED] was in the military and was gone. [REDACTED] said [REDACTED] was a "good guy," he's "not mean," and he treated [REDACTED] well.
